Qualifications

Transportation is provided for all students that are zoned for Lecanto High School; therefore parking is a privilege, not a necessity to attend school. Parking on campus will be offered to those students with the following qualifications:

1. Valid operator driver's license
2. A legally registered vehicle in which the registered owner's name is disclosed to LHS
3. A 2.00 GPA (checked each semester)
4. A signed and completed parking application and \$20.00 non-refundable registration fee
5. Teen Driver Challenge Certificate/Completed Application
6. All obligations must be cleared before purchasing a parking permit.

Revocation

A revocation can result in a loss of parking privilege for a period of time depending on the severity of the discipline; it is at the discretion of the administrator.

1. Failure to maintain a 2.00 GPA
2. Due to disciplinary reasons
3. Taking an ineligible student off campus without authorization
4. Transferring, receiving, or sharing an unauthorized decal.
5. Reckless or careless driving and/or speeding in the parking lot.
6. Leaving campus without properly checking out in the front office. Skipping class/Truancy
7. **Failure to attend assigned Teen Driver Challenge class without minimum of 48 hr. notice will result in revocation of parking permit. If administration is not notified it will result in a 10 day revocation of parking privileges.**

Expectations and Guidelines

1. Students are expected to comply with all state of Florida Traffic Laws while on school property
2. Students may park on campus in their assigned spot only
3. Students may not park in faculty/staff area, visitor parking, labeled spots or off pavement
4. **Illegal parking will result in one warning followed by a \$15.00 fine**
5. Once you have driven into the student parking lot in the morning, you may not leave campus without properly checking out through the appropriate procedures
6. If a student loses his or her parking permit, a replacement fee of \$10.00 will be charged
7. Loitering in the parking lot will not be permitted. Cars should not be used as lockers. Students should return to their cars only when leaving school at the end of the day or after checking out through the proper procedures
8. Vehicles displaying words, graphics, or designs which in the opinion of the school administration are in poor taste, are **PROHIBITED**. No banners, flags, or other loose materials can be hanging from vehicles
9. The administration of Lecanto High School reserves the right to make any adjustments it deems necessary to enforce student – parking regulations to insure the safety and protection of the student population. Florida Law provides for the search of any vehicle on campus by the administration upon reasonable suspicion.
10. Lecanto High School has a **ZERO TOLERANCE** for drugs, weapons, or alcohol.

TO §744.301, FLORIDA STATUTES:**

READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE THE FLORIDA SHERIFFS ASSOCIATION, THE CITRUS COUNTY BOARD OF COUNTY COMMISSIONERS, AND THE OFFICE OF THE SHERIFF OF CITRUS COUNTY, FLORIDA, its members, officers, employees, the promoters, other participants, operators, officials, sponsors, advertisers, owners and lessees of the premises used to conduct the Event, and each of them, their officers and employees, all for the purposes herein referred to as "Releasees," from all liability to the undersigned, his/her personal representatives, assigns, heirs, and next of kin for any and all damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned or the undersigned's minor child, whether caused by the negligence of the Releasees or otherwise while the undersigned or the undersigned's minor child is competing, officiating in, observing, and/or working for, or for any purpose participating in the Event;

2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned or the undersigned's minor child in any way competing, officiating, observing or working for, or for any purpose participating in the Event and whether caused by negligence of the Releasees or otherwise.

3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of Releasees or otherwise and/or while competing, officiating, observing, or working for or for any purpose participating in the Event.

HEREBY expressly acknowledges and agrees that (1) the training course involves moving vehicles being operated by inexperienced drivers; (2) the undersigned's minor child will be operating a vehicle with the express written consent of the owner of the vehicle; and (3) damage may occur to the vehicle that the undersigned's minor child is driving or to other vehicles involved in the course.
