Apple ID For Students Parent Process

Your child will be receiving an Apple iPad at his/her school for use throughout the 2015-2016 school year. Each device requires a unique Apple ID. Each student is required to have his/her own Apple ID to use in association with their device. The process is different based on the age of your student.

Students 13 years and older

If your child is 13 years or older, they will create their own Apple ID. We recommend using their school-based Gmail account and password for their Apple ID. This helps to make it easier to remember and also allows school personnel the ability to more easily assist them with Apple ID login issues, should they arise.

Students 12 years and under

If your child is 12 years of age or under, you, their parent, will create their Apple ID using the steps outlined below. It's important to understand why this program is in place. In 1998, the federal government passed the "Children's Online Privacy Protection Act." This legislation makes it illegal for companies to gather data or personal information of children under the age of 13. To comply with this law, Apple created the Apple ID for Students program putting parents in control of their child's Apple ID. 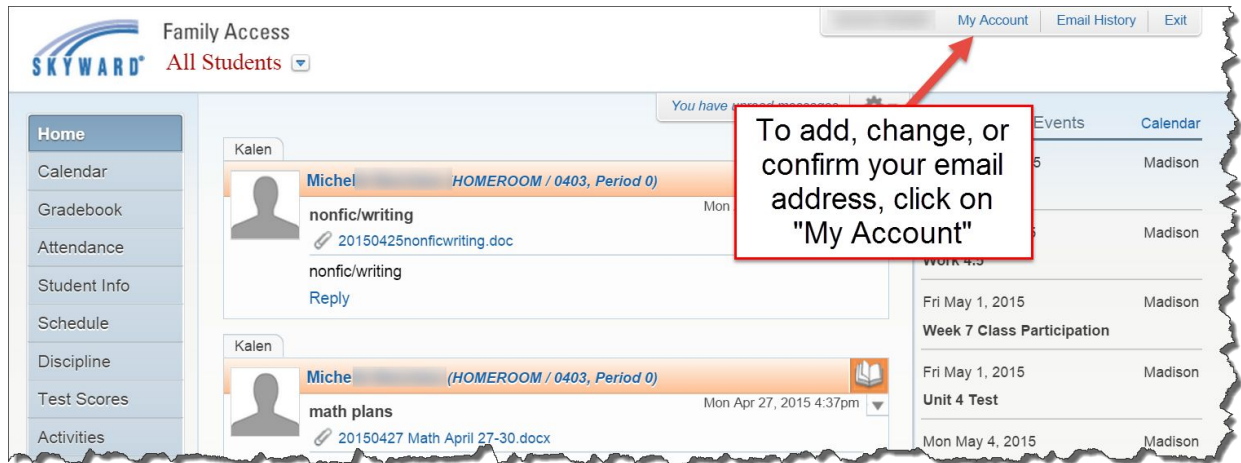

The Apple ID for Students process

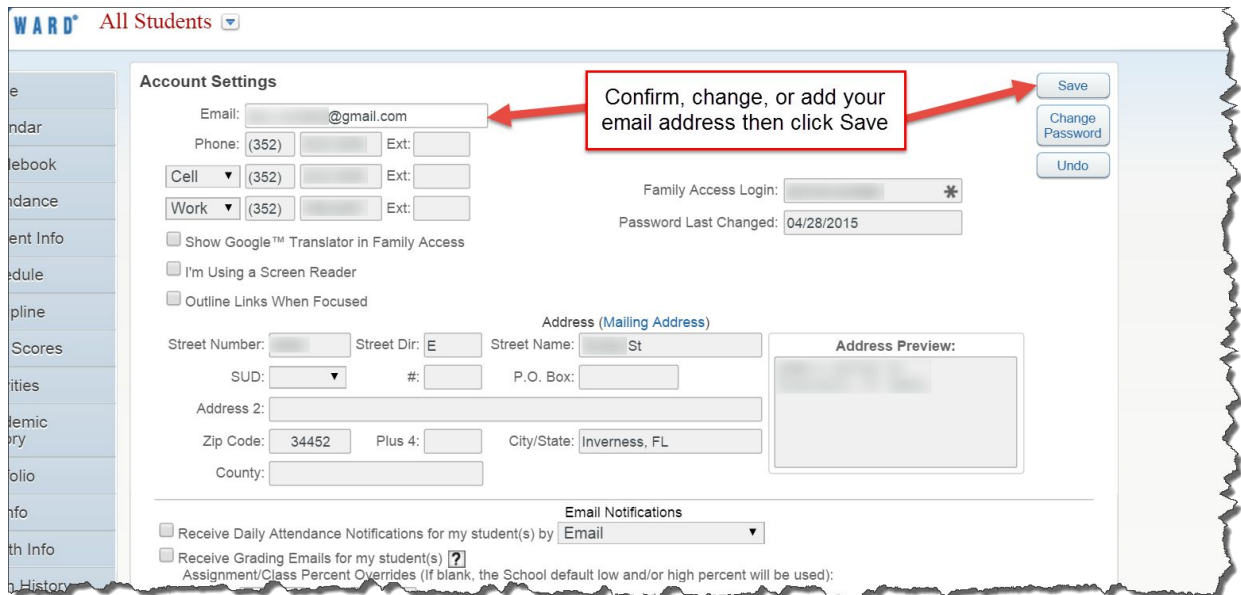
In the next series of screenshots, you'll find the process for creating your student's Apple ID:

Confirming your email address in Skyward

To ensure you receive the email from Apple, it is important to add or change your email address in Skyward. After signing in to Skyward, click on My Account in the upper right.



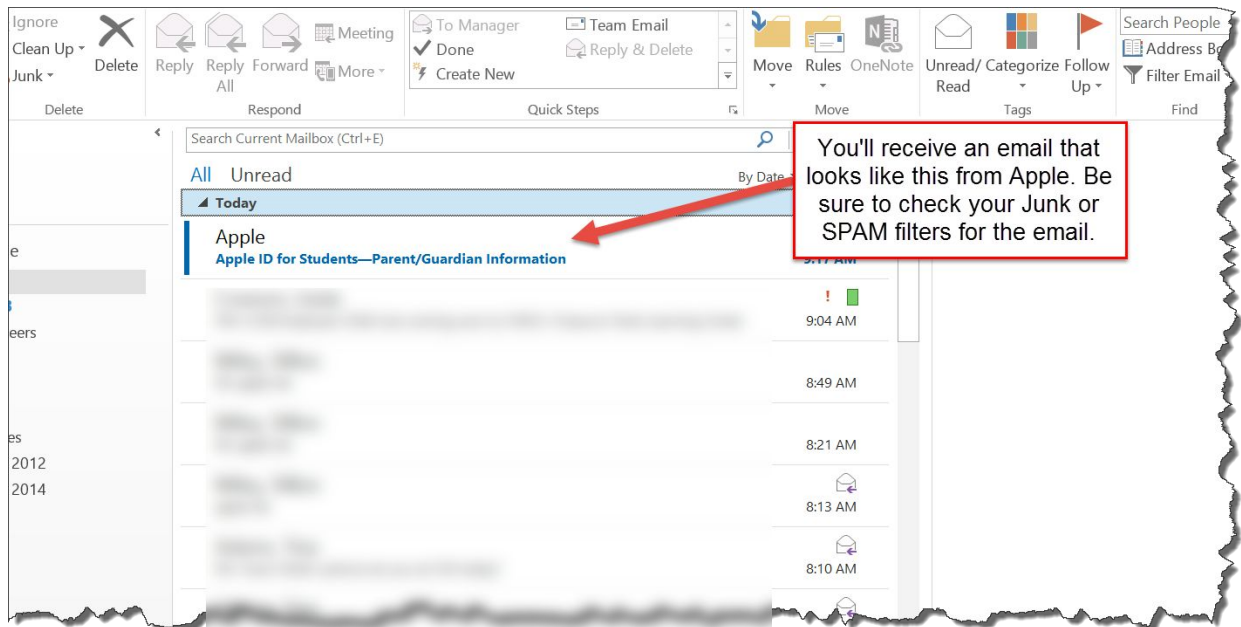
Your email address is the only editable field on this screen. After adding or editing your email address, be sure to click Save or you'll lose that change.

If the email address in Skyward is correct, you'll receive an email from Apple with a subject of "Apple ID for Students--Parent/Guardian Information." Occasionally, this email ends up in your Junk or SPAM filter so be sure to check them if you do not receive the Apple email. In addition, if you believe you should have received the email but have not, please contact your child's school.

Dear Parent or Guardian,

We are excited that your student will be using an iPad or Mac as a part of your school's program. We know that you want the best learning environment for your student—one that makes learning personal for each student and allows for creativity, collaboration, and critical thinking.

Please read this email carefully as it contains important information and instructions.

Apple ID for Students

As part of this program, your student will have an Apple ID—an account with Apple that provides easy access to school materials, like documents and textbooks.

For students under the age of 13, we must obtain your verifiable parental consent before we can create an Apple ID for your student. This is in compliance with the Children's Online Privacy Protection Act (COPPA). You will provide your parental consent by agreeing to the Parent Privacy Disclosure and Consent online.

For students under 13, the following features will apply:

- No credit card is required to set up the account.
- Limit Ad Tracking is turned on for the account to ensure the student does not receive targeted advertising from Apple.
- The accounts are unable to opt in to receive marketing materials from Apple.
- Parents and guardians are notified of material changes to the service or issues with the account.

Creating an Apple ID

To create an Apple ID for your student, go to our [online consent form](#).

You will be asked to enter the following temporary password: M8HH6

Provide the information requested, and you will then be asked to review and agree to the iOS, iCloud, Game Center, and iTunes Store terms and conditions, Apple

You'll be prompted for a password. Find that here. If copying and pasting, be sure there are no spaces added

Parental restrictions

An iPad or Mac can give your student access to a wealth of information. However, there may be times when you want to limit your student's access to certain types of content or resources. On your student's device, you can set restrictions, such as preventing in-app purchases and designating allowable content. Please refer to the [Parent Guide](#) to learn more about setting device restrictions. We strongly encourage you to set device restrictions promptly after creating your student's Apple ID.

If you are copying and pasting this temporary password, be sure there are no spaces accidentally added to the end of the password when it's copied.
