The Citrus County School District is pleased to announce that iPad insurance has been purchased for the new generation 9 iPads provided to our students and teachers.

Important Considerations for Generation 9 IPADS

- Repeated damage or intentional damage may result in charges.
- Loss of the iPad will result in charges.
- Theft of an iPad is covered by the insurance if the family provides a police report.
- The insurance will cover the physical iPad only.

Charges NOT covered by insurance for Generation 9 IPADS

•	Logitech Keyboard case or loss of the keyboard case	\$99.00
•	Brenthaven case or loss of the case	\$35.00
•	Damage to charging block/cord	\$38.00

^{*}Only original Apple brand charging blocks and cords for the generation 9 iPad will be accepted.

Important Information regarding Loaner IPADS

- Loaner iPads will be provided to students if the need for repair arises.
- Please note that the loaner iPad is NOT covered by insurance.

Any damage or loss to the loaner iPad will result in the following fines:

0	Loss or complete damage to the iPad	\$294
0	Loss or complete damage to the loaner iPad case	\$35
0	Loss or damage to the charging block/cord	\$14
0	Cracked screens	\$65
0	Damaged charging ports or audio ports	\$10

We ask that you please review this information with your student and discuss responsible care and use of the iPad.

- 1. Students are expected to use their iPads for educational purposes only.
- 2. Refrain from sharing your iPad or account passwords.
- 3. iPads must be fully charged each day and ready to use for learning. Failure to bring an iPad or any other class material(s) does not release the students from their responsibility for class work.
- 4. Repeated failure to bring the iPad or other class materials may result in disciplinary action.
- 5. If an iPad is missing or stolen, students must report this to staff immediately.
- 6. Return the iPad, charger, and case when withdrawing from the school and at the end of the school year. Failure to do so will result in fines being assessed and the filing of a police report.
- 7. Refrain from utilizing photos, videos, and/or audio recordings of yourself or any other person in an inappropriate manner.
- 8. Use care when handling the iPad as you will be responsible for damage or loss while in your care.
- 9. Never leave the iPad in an unlocked locker, unlocked car, or unsupervised area including locker rooms, the cafeteria, or other areas.
- 10. Always Keep the iPad in the case.
- 11. Screensavers or background photos must be school appropriate.
- 12. Save documents and other work to Google Drive, cloud storage, or email.
- 13. Update the iOS software to the current version.
